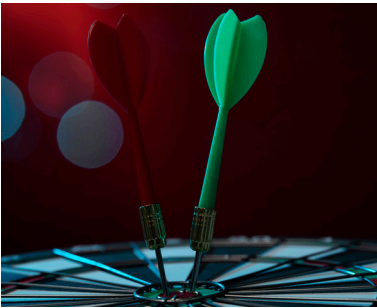

CONGRESS VENUE

The Kigali Convention Centre (KCC) boasts of 18 venues with space for over 5500 attendees. This multifunctional facility can accommodate a wide range of events, from summits with 100 participants to concerts with audiences of over 2500.

PRACTICAL INFORMATION

THE HOST CITY: KIGALI

Ideally positioned in the heart of Rwanda, Kigali spans several hills and valleys, offering excellent road links to the rest of the country. The verdant capital city is pleasantly low-key yet dynamic and progressive, home to just over one million inhabitants. First-time visitors often remark on the cleanliness of the bustling and colourful centre, a source of pride for communities throughout the country.

Kigali is a city where you can experience stunning scenery, beauty, hospitality, culture and the full diversity of Rwanda. Known as the gateway to Rwanda and a tourist hub, Kigali is a residential, educational, commercial and political centre, hosting presidential offices, ministries, accommodation facilities and others. The city operates in the Central African Time zone (GMT+2).

▶ AIRLINES AND TRANSFERS

Kigali International Airport is served by several major airlines: Brussels Airlines, Ethiopian Airlines, Kenya Airways, KLM, RwandAir, Turkish Airlines, Qatar Airways. Akagera Aviation offers helicopter transfers within Rwanda.

Public transportation options include buses, cabs and moto-taxis, but for convenience and safety, using hotel shuttles or pre-arranged cabs is recommended.



▶ IMMIGRATION AND VISAS

Delegates are encouraged to arrange their travel according to their preferences. For international delegates planning to visit Rwanda, you may consult <https://www.migration.gov.rw/> to check your visa requirements.

Important Update: As of 2nd November 2023, Rwanda has announced visa-free entry for all African nationals, eliminating the need for prior visa acquisition. This progressive measure underscores Rwanda's commitment to fostering continental unity and facilitating seamless travel across the region.



▶ ACCOMMODATION

Participants are responsible for their accommodation. Kigali offers a range of hotels and guesthouses to suit various budgets. A list of recommended accommodations can be accessed at <https://tourismregulation.rw/en/entities/1/>. Early booking is recommended to secure preferred options.



▶ WEATHER

In May, Kigali enters the beginning of the dry season, experiencing reduced rainfall compared to previous months. Temperatures typically range from around 15°C to 27°C (59°F to 81°F). While rain is less frequent, occasional showers are still possible. Expect mild and relatively stable weather conditions, but it is always wise to be prepared for changes.



▶ LANGUAGES IN RWANDA

Kinyarwanda is the national language of Rwanda and is the first language for almost the entire population. It is one of the country's official languages, along with French, English and Swahili. To ensure a smooth experience for all delegates, congress staff will be available to assist with any language-related issues. Additionally, simultaneous interpretation will be provided during the plenary sessions of the congress in English, French and Portuguese to accommodate speakers of different languages.



▶ CONNECTIVITY

Wi-Fi is widely available in hotels, restaurants and cafés. Local SIM cards can be purchased for affordable mobile data plans.



CURRENCY AND PAYMENTS

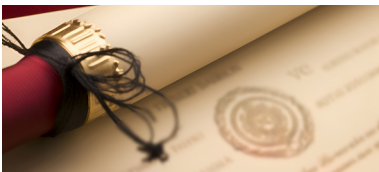
The Rwandan Franc (FRW) is the official currency of Rwanda. Major international currencies can be exchanged at banks and authorised exchange bureaus.

Credit and debit cards are widely accepted in hotels, restaurants and larger stores, but it is advisable to carry some cash for smaller establishments and markets.



HEALTH AND SAFETY

Delegates are advised to have travel insurance that covers health. Malaria is present in Rwanda, so take preventive measures such as using insect repellent and sleeping under mosquito nets. Kigali is generally safe, but usual precautions should be taken, such as avoiding poorly lit areas at night and keeping an eye on personal belongings.



CPD HOURS AND CERTIFICATES

Delegates who attend all sessions will be awarded twenty-one (21) Continuous Professional Development (CPD) hours per the ICPAR CPD Policy.



▶ TOUR ACTIVITIES

Known as the land of a thousand hills, Rwanda's stunning scenery and warm, friendly people offer unique experiences. It is blessed with extraordinary biodiversity, with incredible wildlife living throughout its volcanoes, montane rainforest and sweeping plains. Travellers come from far and wide to catch a glimpse of the magnificent scenery.
